At 1201 Bell Avenue in Tustin, California, we advanced our commitment to energy efficiency and operational sustainability by replacing four aging HVAC units, totaling 33.5 tons, representing 21% of the building's total cooling capacity across 126,957 square feet of warehouse space. This proactive investment not only enhances building performance and indoor comfort but also delivers meaningful energy savings for our tenant. By extending the life of the asset and improving system efficiency, we continue to create value through responsible property management and sustainable building practices.
